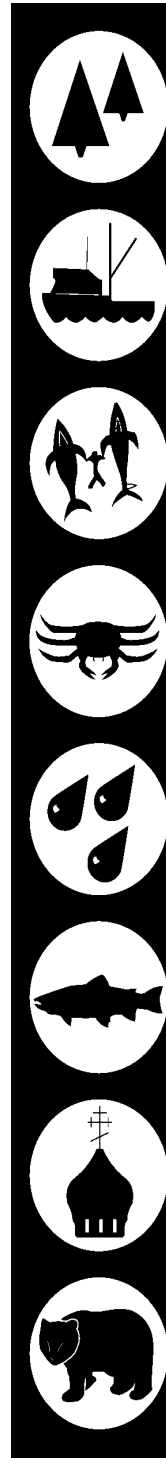

The Native Education Program is a federally funded grant program and provides services, activities, and resources for Native students and their families.

### **Are you, your child, or their grandparent an Alaska Native or American Indian?**

If so, your child may be able to enroll in Title VI Native Education Program.

Enrollment will increase opportunities available for your Native student. The program's goal is to help Native students meet and exceed state academic and cultural standards.

## Native Education Parent Committee

### **Parents are encouraged to provide input by joining the parent committee!**

The Native Education Parent Committee is established under the guidelines of the U.S. Department of Education's Office of Indian Education.

#### **The committee is responsible for:**

- Approving the Annual Title VI Grant Application
- Advising the District and School Leaders on the cultural needs of Native students
- Monitoring the Native Education program on behalf of the native communities of Kodiak

#### **Members of the committee include:**

- Greater than 50% parents of program eligible students, elected in a general election
- At least one teacher, appointed by the committee
- A representative from the School Board

Meetings are always open to the public and involvement of parents, students, and community leaders is encouraged. To join the NEPC, please contact the Federal Programs Office.

## **An Alaska Native or American Indian is defined as:**

- A member (as defined by the Indian tribe or band) of an Indian tribe or band, including those Indian tribe or bands terminated since 1940, and those recognized by the state in which the tribe or band reside.  
**or**
- A descendent in the first or second degree (parent or grandparent) as described in (1)  
**or**
- Considered by the Secretary of the Interior to be an Indian for any purpose  
**or**
- An Alutiiq, Aleut, or other Alaska Native  
**or**
- A member of an organized Indian group that received a grant under the Indian Education Act of 1988 as it was in effect

## **Title VI Student Eligibility Certificate (506 Form)**

The Federal Programs Office must have an original form on file for all students enrolled in the Native Education Program. **A 506 Form is only complete if it contains a tribal membership number or a copy of a Certificate of Indian Blood.** Once enrolled, the student will remain eligible for as long as they
